Expertise required by the applicant	The successful applicant will have significant research and business management experience in business economics, corporate responsibility and reputation, performance management and strategy. Minimum experience is Ph.D. and/or M.B.A. with at least 4 year’s research and/or business experience post qualification.
Career development support offered to fellows	AIHPC offers the researcher a unique opportunity to work within a collaborative organisation of academic institutes, hospices and palliative care providers, service users and their carers and funding organisations in the Republic of Ireland and Northern Ireland. The Institute will provide the fellow with dual supervisory and mentoring support from both an economic and social policy academic and a business management mentor. We will also provide information, education and support in palliative care and non-profit organisations via the Institute team, palliative hub , and partner organisations. There will be networking and career development opportunities for the fellow to immerse themselves into the sector through on-site visits to our collaboration centres on the island of Ireland.
